# Colorado County Fair Rodeo Business Ribbon Roping

1. Runner, Roper, and Mugger must be over 16 years old.
2. If you do not have a roper, one will be provided for you.
3. Entries are limited to the first 10 teams entered each night. PRE-ENTRY ONLY. Entries must be post marked by September 5, 2023.

4. The mugger and the runner of the winning team with the fastest time of the night will each receive a belt buckle during the performance.
5. The roper will rope the calf and once the mugger has a hold of the calf, the runner shall take the ribbon off the calf's tail and run back to the starting line to get a time.
6. There is a one loop limit for the roper.
7. The mugger must have hands on the calf BEFORE and WHEN the ribbon is pulled, or it is a no time. **The judge's call is final.**
