# Colorado County Fair Rodeo Junior Barrel Race

1. Ages 18 and under. Contestant must still be in high school or under.
2. Contestant's must live in Colorado County or parents own a business in Colorado County to be eligible to participate.
3. Contestants must have their own horse.
4. Contestants must wear long pants, long sleeve western shirt, and boots. Hats optional.
5. If the rodeo committee determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or horse, then the committee reserves the right to disallow the ride. **The decision of the committee is final.**
6. Performance entries are limited to the first 5 contestants pre-entered each night. Entries are due September 5, 2023. If more than 10 entries are received all others will run after the barrel slack on Friday night.
7. There will be no age divisions for the youth barrel race.
8. One buckle will be given to the fastest time of ALL runs (perfs and slack).
