RELEASE AND WAIVER OF LIABILITY AGREEMENT

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS ACTIVITIES AND THAT MY CHILD COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY HAVEING MY CHILD PARTICIPATE IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

Warning: Under Texas Law (Chapter 87, Civil Practice and Remedies Code), a livestock show sponsor is not liable for an injury to or the death of a participant in a livestock show resulting from the inherent risk of livestock show activities.

As consideration for being permitted by the Fair, the State of Texas ("State"), the County of Colorado (the "County"), and any lessor of the fair premises ("Lessor"), to participate in these activities and use the Fair premises and facilities, I forever release the Fair, the State, the County, the Lessor, any affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasee") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my child's participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by and Releasee, or (iii) the condition of the premises where these activities occur, whether or not my child is then participating in the activities. I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any release in connection with any of the matters covered by the foregoing release.

Colorado County Fair Rodeo Mutton Bustin' Rules

1. Ages 3 to 6.
2. Contestants must not weigh more than 55 pounds.
3. Contestants must wear long pants.
4. Contestants must wear closed toed shoes.
5. Helmet **MUST BE WORN** (helmet will be provided).
6. If the Mutton Bustin' Chairperson determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or sheep, then the said Chairperson reserves the right to disallow the ride. **The decision of the Chairperson is final.**
7. Entries are limited to the first 50 contestants entered each night. NO PRE-ENTRIES. You must enter under the announcer stand from 5:45pm until full or until 7:00pm the night of your ride.
8. Only the top ten riders will come back and ride a second sheep during the rodeo performance the same night.
