Calf Scramble **Friday, Sept 12th:** Rodeo for ages 13 & above. Only hog, Ag mech, goat,lamb,broilers or rabbits.

The exhibitor is choosing to show: Mkt Hog, Mkt Goat, Ag Mech, or Mkt Lamb. Exhibitor will receive \$300

The exhibitor is choosing to show Broilers or Fryer Rabbits. The exhibitor will receive \$100.

Calf Scramble **Saturday, September 13th** at rodeo for ages 13 & above. Only for exhibitors choosing to show: Mkt Steer, Commercial Heifer, Pen of Two Heifers, or a Jr. Breeding Heifer. The exhibitor will receive \$1,000.
