RELEASE AND WAIVER OF LIABILITY AGREEMENT

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS ACTIVITIES AND THAT MY CHILD COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY HAVEING MY CHILD PARTICIPATE IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

Warning: Under Texas Law (Chapter 87, Civil Practice and Remedies Code), a livestock show sponsor is not liable for an injury to or the death of a participant in a livestock show resulting from the inherent risk of livestock show activities.

As consideration for being permitted by the Fair, the State of Texas ("State"), the County of Colorado (the "County"), and any lessor of the fair premises ("Lessor"), to participate in these activities and use the Fair premises and facilities, I forever release the Fair, the State, the County, the Lessor, any affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasee") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my child's participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by and Releasee, or (iii) the condition of the premises where these activities occur, whether or not my child is then participating in the activities. I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any release in connection with any of the matters covered by the foregoing release.

Junior Barrel Race

1. Ages 18 and under. Contestant must still be in high school or under.
2. Contestants must live in Colorado County or parents own a business in Colorado County to be eligible to participate.
3. Contestants must have their own horse.
4. Contestants must wear long pants, long sleeve western shirt, and boots. Hats optional.
5. If the rodeo committee determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or horse, then the committee reserves the right to disallow the ride. **The decision of the committee is final.**
6. Performance entries are limited to the first 5 contestants pre-entered each night. Entries are due September 4, 2026. If more than 10 entries are received all others will run after the barrel slack on Friday night.
7. There will be no age divisions for the youth barrel race.
8. One buckle will be given to the fastest time of ALL runs (perfs and slack).
